## **PREAMBLE**

This Entry Manual sets out the principles for allocating slots to Member Associations and their eligible clubs to participate in the ASEAN Club Championship from the 2025/26 Sporting Season onwards.

This Entry Manual shall be read in conjunction with the relevant competition regulations and circulars. This Entry Manual shall form an integral part of any such competition regulations and/or circulars.

## DEFINITIONS

In this Entry Manual, capitalised terms shall have the following meanings, unless the context specifically indicates otherwise:

<b>ACC</b>	The ASEAN Club Championship.
<b>AFC</b>	The Asian Football Confederation.
<b>AFC Men's Club Competition Ranking</b>	A ranking of the Member Associations based on the results of all their clubs in the AFC Men's Club Competitions determined in accordance with Appendix 1 to this AFC Men's Club Competitions - Entry Regulations, in force at the time.
<b>Entry Manual</b>	This ASEAN Club Championship – Entry Manual.
<b>Member Association Eligibility Criteria</b>	The criteria as set out in Article 5 of this Entry Manual.
<b>Sporting Criteria</b>	The criteria as set out in Article 8 of this Entry Manual.
<b>Sporting Season</b>	The period starting with the first official match of a competition and ending with the last official match of the relevant competition.
<b>Titleholder</b>	The champion of the most recently concluded edition of an ASEAN Club Competition.

For the purposes of this Entry Manual, and provided the context so permits:

- (i) the singular shall include the plural and vice-versa;
- (ii) the feminine gender shall include the masculine and vice-versa;
- (iii) references to natural persons shall include any legal person or corporation;
- (iv) references to the AFF shall include its successors and permitted assigns and, where the context requires, the AFF Committees;
- (v) references to the AFF Commercial Rights Partner or Commercial Affiliates shall include, where advised by the AFF, their successors and permitted assigns; and
- (vi) all defined terms, unless otherwise stated herein shall bear the same meaning as ascribed in the AFF Statutes, the relevant AFF Competition Regulations, the AFC Competition Operations Manual and the AFC Club Licensing Regulations, unless the context indicates otherwise.

## **SECTION 1: GENERAL PROVISIONS**

### **1. Scope of Application**

- 1.1. This Entry Manual governs the entry of clubs into the ASEAN Club Championship from the 2025/26 Sporting Season onwards.
- 1.2. This Entry Manual sets out the mechanism for allocating slots to Member Associations and their eligible clubs to participate in the ASEAN Club Championship.
- 1.3. Any reference to the AFF Statutes and to AFF and FIFA regulations refers to those in force at the time of application.

### **2. AFC Men's Club Competitions Ranking**

- 2.1. The AFF shall refer to the AFC Men's Club Competitions Ranking, as published by the AFC in accordance with the relevant AFC regulations, each year.
- 2.2. The AFF General Secretariat shall allot slots to the eligible Member Associations for the Asean Club Championships, in accordance with the provisions set out in this Entry Manual, from the 2025-26 Season.

## **SECTION 2: Slot Allocation**

### **3. Slot Allocation**

3.1. Subject to the other relevant provisions within this Entry Manual, Member Associations have been allocated the following slots for the 2025-26 season:

#### **3.1.1. PLAY-OFF STAGE**

- a. One (1) Participating Club each from the AFF Member Associations (the “AFF MAs”) securing bottom-four rank in the immediately preceding AFC Men’s Club Competitions Rankings, that has been published as on the date of publication of the Tournament Regulations for the relevant Season.
- b. The Participating Club as mentioned hereinabove, shall be the winners of the National League season within the respective Member Association.
- c. For the avoidance of any doubts, even if a Participating Club from one of the AFF MAs securing bottom-four rank as per Article 3.1.1 a, hereinabove has participated in the previous Season of the ASEAN Club Championship, such Participating Club shall not be eligible to participate in the next Season of the ASEAN Club Championship unless they fulfill Article 3.1.1 b.

#### **3.1.2. GROUP STAGE**

This stage shall have a total of twelve (12) teams:

- a. Two (2) Participating Clubs each from the Member Associations of the following:
  - i) Malaysia
  - ii) Singapore
  - iii) Thailand, and
  - iv) Vietnam;
- b. One (1) Participating Club from the AFF Member Association not included in Article 3.1.2 (a), hereinabove

and ranked at the top of the table at the end of the immediately preceding AFC Men's Club Competitions Rankings, that has been concluded as on the date of publication of the Tournament Regulations for the relevant Season, and;

- c. Two (2) Participating Club(s) being the winners of the Play-Off stage as mentioned in Article 3.1.1, hereinabove.
- d. Should a Participating Club from one of the AFF MAs mentioned in Article 3.1.2 a or 3.1.2 b, be adjudged as the winner of the previous Season of the ASEAN Club Championship, then such an AFF MA shall receive a direct Titleholder slot over and above the number of slots allotted as per Article 3.1.2 (a) or Article 3.1.2 (b). The winner of the previous Season of the ASEAN Club Championship shall be allotted a slot as per Article 4 hereinbelow and be seeded higher than the other Participating Club(s) of the said AFF MA.
- e. The Participating Clubs for AFF MAs mentioned in Articles 3.1.2.a shall be (i) the winners of the National League season and (ii) the winners of the National Cup knock-out competition each.
  - (i) If the same Participating Club is the winner of the National League and the National Cup, then the next best placed Club in the National League shall be deemed eligible, provided they fulfil requirements set out in Article 6.1.
  - (ii) If the winner of the National League does not fulfil the requirements set out in Article 6.1, the next best placed Club in the National League shall be deemed eligible, provided they also fulfil requirements set out in Article 6.1.
  - (iii) If the winner of the National Cup knock-out competition does not fulfil the requirements set

out in Article 6.1., the runner-up of the National Cup knock-out competition shall be deemed eligible, provided they also fulfil requirement set out in Article 6.1.

(iv) Should the runner-up of the National Cup knock-out competition also does not fulfil the requirements, the AFF shall reserve the right to determine the replacement team through consultation with the respective Member Association.

(v) If the Member Association does not have a National Cup knock-out competition, then the next best placed Club in the National League shall be deemed eligible, provided they fulfil requirements set out in Article 6.1.

f. The Participating Club for AFF MAs mentioned in Article 3.1.2b. and c. shall be the winners of the National League season.

g. For the avoidance of any doubts, even if a Participating Club from one of the AFF MAs as per Articles 3.1.2 a and b, hereinabove has participated in the previous Season of the ASEAN Club Championship, such Participating Club shall not be eligible to participate in the next Season of the ASEAN Club Championship unless they fulfill Article 3.1.2 (e), hereinabove.

3.2. For the avoidance of doubt, the AFF General Secretariat has the right to make any necessary adjustments to the slot allocations set out in Articles 3.1.1 and 3.1.2 in the manner provided for in this Entry Manual. The adjusted slot allocation will be notified to the Member Associations by circular letter.

3.3. Subject to other relevant provisions within this Entry Manual, Member Associations shall be allocated the following provisional slots for 2025-26 season onwards, in accordance with the following:

\* The additional (+1) slot is for the Titleholder of the immediately preceding ACC Sporting Season. Thus, it shall be applicable to only one of the teams mentioned herein.

\*\* The AFC Men's Club Competitions Rankings published by the AFC immediately preceding the commencement of the ACC Sporting Season in a given year.

NOTE: For the purposes of slot allocation as per Table 1.2 hereinabove, the Member Associations mentioned in Table 1.1 shall not be counted in the AFC Men's Club Championship Rankings mentioned in Table 1.2. Therefore, the immediately succeeding Member Association as per the AFC Men's Club Competitions Rankings shall be awarded the slots.

- 3.4. For the avoidance of doubt, the AFF General Secretariat has the right to make any necessary adjustments to the slot allocations as set out hereinabove, in the manner provided for in this Entry Manual. The adjusted slot allocation shall be notified to the Member Associations by circular letter.

#### **4. Slots for Titleholder**

- 4.1. The Titleholder of the preceding edition of the ACC shall be allocated a

direct slot into the Group Stage of the following edition of ACC.

- 4.2. The Titleholder shall be allocated the relevant slot as per Article 4.1 even if they do not qualify for the relevant ACC by virtue of failing to meet the Sporting Criteria.
- 4.3. Notwithstanding Articles 4.1 and 4.2, the Titleholder must meet the eligibility requirements set out in Articles 5, 7 and 9 in order for the relevant slot to be allocated to them.
- 4.4. Unless decided otherwise by the AFF, where the ACC Titleholder participates in the following edition of the ASEAN Club Championship, it shall, for operational purposes (e.g. seeding for entries, draws,) be deemed to be the highest-seeded club of the ACC Group Stage.

#### Principles of Redistribution of Slots

- 4.5. A redistribution of direct slots shall occur in accordance with Article 4.5, in case where:
  - 4.5.1. any Member Association fails to fulfil any of the Member Association Eligibility Criteria; or
  - 4.5.2. any Member Association has more direct slots allocated to it than the number of its eligible clubs (cf. Section 3); or
  - 4.5.3. the Titleholder fails to meet the eligibility requirements set out in Article 5, 7 and 9; or
  - 4.5.4. otherwise expressly provided for in this Entry Manual.
- 4.6. In case of redistribution of direct slots, subject to Articles 4.7 and 4.8, any direct slot(s) that were forfeited shall be redistributed to the next highest eligible Member Association in the AFC Men's Club Competitions Ranking.
  - 4.6.1. Should a Member Association receive direct slot(s) via a redistribution, an equal number of indirect slot(s) already allocated to the Member Association (if any) shall be annulled and such slot(s) shall not be redistributed (e.g., 2+1 becomes 3+0)

- 4.7. For the avoidance of doubt, any indirect slot which is not allocated to an eligible club shall be annulled and not be redistributed.

Maximum Number of Slots allocated to a Member Association

- 4.8. Subject to the provisions of this Entry Manual, the maximum number of slots allocated to a Member Association in ACC shall be limited to the following:

*\* The additional (+1) slot is for the Titleholder of the immediately preceding ACC.*

## **SECTION 3: ELIGIBILITY CRITERIA**

### **5. Eligibility of Member Associations**

- 5.1. For the purposes of 2025-26 season onwards, the Member Associations must meet the Member Association Eligibility Criteria as set out in the then-current AFC Club Competitions Entry Manual/Regulations, by whatever name called, in order to be eligible to obtain direct slots for the relevant ACC.
- 5.2. Any Member Association which fails to fulfill the Member Association Eligibility Criteria as mentioned hereinabove, shall be eligible to be allocated only indirect slots for the relevant ACC.
- 5.3. Should a Member Association fail to meet the minimum conditions set out in the AFC Club Competitions Entry Manual/Regulations, the indirect slot(s) allocated to the relevant Member Association shall be annulled.

### **6. Eligibility of Clubs**

- 6.1. To be eligible to participate in the ACC, a club must:
  - 6.1.1. be granted a license in accordance with Article 7;
  - 6.1.2. meet the Sporting Criteria; and
  - 6.1.3. comply with the rules on the integrity of the ASEAN Club Championship as set out in Article 9.
- 6.2. In case of failure to meet any of the criteria defined in Article 6.1, a club shall be considered ineligible to participate in the ACC. Accordingly, such club(s) shall be replaced by the next-best seeded eligible club from the same Member Association in accordance with Article 8.3.

### **7. Club Licensing Criteria**

- 7.1. Member Associations are required to implement a national club licensing system for all the clubs within their domestic top division league, in accordance with the AFC Club Licensing Regulations.
- 7.2. Clubs that meet the Sporting Criteria must have validly received a license from the relevant national licensor as also the AFC.

### **8. Sporting Criteria**

- 8.1. Subject to the relevant provisions of this Entry Manual, each Member

Association shall set the methodology for nomination of its representative club(s) for the ASEAN Club Championship. Notwithstanding the foregoing, each Member Association shall ensure that, without exception:

- 8.1.1. its club(s) qualify for the AFF Club Competition based on sporting merit;
  - 8.1.2. it clearly identifies a domestic top division league and domestic cup (if applicable) for the purposes of this Entry Manual;
  - 8.1.3. the highest-seeded club nominated by the Member Association shall be the winner of its domestic top division league and/or domestic top division cup, as the case may be. In case the domestic top division league consists of different formats (e.g., a Knockout Stage after the completion of a League Stage), the Member Association shall be responsible for determining the winner of the domestic top division league as part of its nomination principles;
  - 8.1.4. the principles of objectivity, transparency and non-discrimination are respected with a view to ensuring fair entry into the AFF Club Competition; and
  - 8.1.5. the nomination principles are approved by the relevant competent bodies within its Member Association and/or League prior to submission to the AFF.
- 8.2. Member Associations shall submit a list of eligible clubs with their respective seedings for the relevant ACC in accordance with the principles set out in this Entry Manual to the AFF in writing by no later than 15<sup>th</sup> April preceding the start of the relevant Season.
- 8.2.1. For example, in a domestic top division league of twelve (12) clubs, only the top six (6) are eligible to participate in the AFF Club Competition on the basis of their finishing position.
  - 8.2.2. For the avoidance of doubt, if the same domestic top division league commenced the Sporting Season with twelve (12) clubs, but only ten (10) completed the full Sporting Season for whatever reason, the top six (6) are eligible to participate in the AFF Club Competition on the basis of their finishing position.
  - 8.2.3. For the avoidance of doubt, when calculating the number of clubs that participated on the first match day of a domestic top

division league and the final finishing position, 'foreign clubs' (i.e., clubs which are not affiliated to the relevant Member Association) shall not be considered. The AFF General Secretariat has the sole discretion to determine whether a club shall be considered 'foreign' for the above purpose.

8.3. This Article 8 shall only take into consideration the domestic top division league and domestic cup ending in the domestic Sporting Season immediately preceding the relevant AFF Club Competition.

8.3.1. Where there was no domestic top division league and/or domestic cup(s) held in the domestic Sporting Season immediately preceding the relevant AFF Club Competition, the relevant Member Association shall submit a written proposal to nominate the representative club(s) to the AFF for its approval by no later than the deadline stipulated in Article 8.2.

#### Eligible Club refuses to enter AFF Club Competition

8.4. If an eligible club refuses to enter any AFF Club Competition, despite meeting the criteria in accordance with Article 6.1, the slot(s) allocated to its Member Association shall be:

8.4.1. for any direct slot(s): redistributed in accordance with Article 4.5;

8.4.2. for any indirect slot(s): annulled and not redistributed.

### **9. Integrity of ASEAN Club Championship**

9.1. To ensure the integrity of ASEAN Club Championship, clubs shall comply with all the provisions of this Article 9.

9.2. Decisions of the AFF shall be made in accordance with the relevant rules, regulations and circulars etc., in force at the time, including the Procedural Rules Governing the AFC Entry Control Body.

#### Clubs directly or indirectly involved in Match Manipulation

9.3. If, on the basis of all the factual circumstances and information available to it, the AFF concludes to its comfortable satisfaction that a club has been directly and/or indirectly involved, since the entry into force of Article 64 (6) of the AFF Statutes (or its future equivalents), in any activity aimed at arranging or influencing the outcome of a match at national or international level, such club shall be declared ineligible

to participate in the AFF Club Competition. Such ineligibility is effective for only one (1) Sporting Season.

- 9.3.1. When making this administrative decision, the AFF can rely on, but is not bound by, a decision of a national or international sporting body, arbitral tribunal or state court.
- 9.3.2. The AFF can refrain from declaring a club ineligible to participate in the AFF Club Competition if it is comfortably satisfied that the impact of a decision made in connection with the same factual circumstances by a national or international sporting body, arbitral tribunal or state court has already had the effect to prevent that club from participating in an AFF Club Competition.

#### Control or Influence of Clubs

- 9.4. The following criteria aim to safeguard the integrity of the ACC and its matches. Clubs must be committed to ensuring that they conform to the highest ethical and sporting standards regarding matters of control and influence.

In this regard:

- 9.4.1. No participating club may, either directly or indirectly:
  - 9.4.1.1. hold or deal in the securities or shares of any other participating club;
  - 9.4.1.2. be a member of any other participating club;
  - 9.4.1.3. be involved in any capacity whatsoever in the management, administration and/or sporting performance of any other participating club; and/or
  - 9.4.1.4. have any power whatsoever in the management, administration and/or sporting performance of any other participating club, if there is a material risk that such circumstance(s) would actually or potentially jeopardise the integrity of an ACC and/or any match in an ACC.
- 9.4.2. No individual or legal entity may simultaneously be involved, either directly or indirectly, in any capacity whatsoever in the management, administration and/or sporting performance of more than one (1) participating club if there is a material risk

that this would actually or potentially jeopardise the integrity of an ACC and/or any match in an ACC.

- 9.4.3. No individual or legal entity may have control or influence over more than one (1) participating club if there is a material risk that this would actually or potentially jeopardise the integrity of an ACC and/or any match in an ACC.

In this context, control or influence shall be defined as:

9.4.3.1. holding a majority of the shareholders' voting rights in the relevant participating club(s);

9.4.3.2. having the right to appoint or remove a majority of the members of the administrative, management, or supervisory body of the relevant participating club(s);

9.4.3.3. being a shareholder and alone controlling a majority of the shareholders' voting rights in the relevant participating club(s) pursuant to an agreement entered into with other shareholders of the relevant participating club(s); and/or

9.4.3.4. being able to exercise by any means a decisive influence in the decision-making of the relevant participating club(s).

- 9.5. The burden of proof shall rest on the relevant club to prove its compliance with the provisions of Article 9.4 and the AFF shall be entitled, at its discretion, to request information from the relevant club in this regard.

- 9.6. If the AFF considers that any clubs may not or do not comply with Article 9.4, it shall refer the matter to the relevant AFF body/authority including without limitations, the AFF Disciplinary and Ethics Committee. The decisions made in this regard by the relevant AFF body/authority shall be final.

- 9.7. If the non-compliance is determined prior to the relevant clubs' participation in the ACC, then the relevant AFF body/ authority shall determine the next steps at its discretion, in accordance with the relevant rules, regulations and circulars etc., in force at the time including the Procedural Rules Governing the AFC Entry Control Body,



having regard to the importance of safeguarding the integrity and smooth operation of the ACC and matches in the ACC.

9.8. If the non-compliance is determined after the relevant clubs' participation in the ACC, then the relevant clubs shall be permitted to complete the ACC, however, the relevant clubs shall be declared ineligible to participate in the ACC for the following two (2) Sporting Seasons.

9.9. For the avoidance of doubt, nothing in this Entry Manual shall be interpreted as limiting the ability of the AFF to initiate disciplinary proceedings in accordance with the AFF Disciplinary and Ethics Code.

## **10. Appeal**

10.1. Any appeal against a decision of the relevant AFF body/authority with regards to the eligibility of a Club to participate shall be made exclusively before the Court of Arbitration for Sport (CAS) within ten (10) days of notification of the decision.

10.2. Appeals shall be subject to the following limitations:

10.2.1. the appeal shall automatically be subject to an expedited procedure and be completed (if relevant) prior to the Competition draw;

10.2.2. the appeal shall be heard by three (3) arbitrators;

10.2.3. the appeal shall be conducted in English; and

10.2.4. any hearing, if required, shall be at the CAS Alternate Hearing Centre in Kuala Lumpur, Malaysia.

## **SECTION 5: CLOSING PROVISIONS**

### **11. Draw Mechanism**

- 11.1. The draw mechanism for the ASEAN Club Championship shall be published by the AFF General Secretariat in advance of any draw.

### **12. Disciplinary Measures**

- 12.1. All disciplinary measures in relation to this Entry Manual shall be undertaken in accordance with the current AFF Statutes, AFF Disciplinary and Ethics Code and any relevant AFF circular.

### **13. Decisions**

- 13.1. All decisions made in accordance with this Entry Manual, except where expressly identified otherwise, are final and binding and not appealable in accordance with the AFF Statutes.

### **14. Amendments**

- 14.1. The AFF reserves the right to make amendments to any part of this Entry Manual for any reason whatsoever. Such amendments shall be duly communicated to the Member Associations and clubs in due course.

### **15. Matters Not Provided For**

- 15.1. Matters not provided for in this Entry Manual shall be decided by the AFF Competitions Committee. Such decisions are final, binding and not appealable.

### **16. AFF Statutes**

- 16.1. To the extent that this Entry Manual is inconsistent with the AFF Statutes, the AFF Statutes shall prevail.
- 16.2. To the extent that this Entry Manual is inconsistent with any AFF Regulations, this Entry Manual shall prevail.

### **17. Implementing Provisions**

- 17.1. The AFF General Secretariat is entrusted with the operational management of the ASEAN Club Championship and is therefore entitled to make decisions and adopt the detailed provisions necessary for implementing this Entry Manual.

## **18. Enforcement**

18.1. This Entry Manual was ratified by the AFF Competitions Committee on 28 June 2025 and, subject to Article 18.2 of this Entry Manual, came into force immediately.

18.2. This Entry Manual shall be applicable to the ASEAN Club Championship from the 2025/26 Sporting Season onwards.
